The Corporate Carbon Footprint

The corporate carbon footprint (CCF) comprehensively assesses the carbon footprint of your company by recording and calculating climate-relevant consumption data. The creation of a CCF is the starting point for the reporting of company-related greenhouse gases and for the partial or full financing of climate protection projects to the extent of the calculated company emissions. The footprint forms the basis for corporate climate protection.

Methodology

The CCF – also known as a the CO₂ footprint, carbon footprint or greenhouse gas inventory – records the overall volume of company-related greenhouse gas emissions that arise both with respect to company sites and along the value chain. The emissions that have arisen over 12 months are retrospectively considered and established in tonnes of CO₂ equivalents (CO₂ eq. according to IPCC 2017 GWP 100a) per year. The basis for establishing and reporting a CCF takes place according to internationally recognised standards.
